are no special circumstances or other basis for costs to be ordered against the Plaintiff on indemnity basis in respect of the case management stay sought. It was only on the day before the hearing of the Summons that the 2nd Defendant produced the undertaking by the 1st Defendant, to abide by any award made in the Arbitration as to the 2nd Defendant's liability under the Contract, and this was an important consideration in the Court's grant of the case management stay. I accept the Plaintiff's submissions, \mathbf{G} that its costs in preparation for the stay application had been incurred on the basis that no such undertaking was provided, and that the associated Н costs should not be awarded to the 2nd Defendant. Without the application under section 20 of the Ordinance, the case management stay, even if granted, would in all probability have been granted with costs in the

7. As for the stay under section 20 of the Ordinance, the authorities have made it clear that a party takes the risks of an indemnity costs order against it in the event of an unsuccessful challenge of an arbitration agreement or an arbitral award made pursuant to such agreement. The principles for the grant of a stay have been clearly set out in the authorities, and it is sufficient if a prima facie case of the existence of an arbitration agreement is established. I agree with the Plaintiff that it was unnecessary for the 2nd Defendant to file evidence on the details of the underlying disputes, and much of the evidence was totally ignored at the hearing of the Summons.
