

- All Member States of EU have signed the UPCA except Spain, Poland and Croatia.
- Of the 24 Member State signatories to the UPCA:
- 17 have already ratified/deposited the ratification instrument for the UPCA (including France, Italy, the Netherlands, etc.).
- The UP/UPC went into force in the seven other Member States from the date they have ratified/deposited the ratification instrument for the UPCA.
